Mec-Oild di Poletti Roberto (hereinafter "Mec-Oild") processes personal data (for example, name, surname, address, telephone number, email address, taxpayer identification number, VAT identification number, bank details) provided by the data subject or obtained from publicly accessible sources. Mec-Oild website (<http://www.mec-oild.com>) does not use cookies and Mec-Oild does not collect website browsing information.

The processing of the personal data is carried out:

- for specific purposes for which the data subject has given consent to the processing (for example, for marketing purposes), in accordance with point (a) of Article 6(1) of GDPR;
- if it is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract, in accordance with point (b) of Article 6(1) of GDPR;
- if it is necessary for compliance with a legal obligation to which Mec-Oild is subject (for example, to issue invoices, waybills), in accordance with point (c) of Article 6(1) of GDPR;
- if it is necessary for the purposes of the legitimate interests pursued by Mec-Oild or by a third party (for example, for direct marketing purposes), in accordance with point (f) of Article 6(1) of GDPR.

Mec-Oild may share the personal data with public authorities (for example, Italian Revenue Agency), credit institutions, professional advisors (for example, accounting firms), service providers (for example, shipping companies).

Mec-Oild does not intend to transfer personal data to a third country or international organisation.

The personal data are stored for no longer than is necessary for the purposes for which the personal data are processed. However, in some circumstances the personal data are stored for longer periods of time (for example, to comply with legal, tax or accounting obligations or to have an accurate record in the event of any complaints or challenges).

The data subject has the right:

- to request access to personal data concerning him or her;
- to request rectification of personal data concerning him or her;
- to request erasure of personal data concerning him or her;
- to request restriction of processing of personal data concerning him or her;
- to object to processing of personal data concerning him or her;
- to data portability of personal data concerning him or her;
- where the processing is based on point (a) of Article 6(1) of GDPR or point (a) of Article 9(2) of GDPR, to withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal;
- to lodge a complaint with a supervisory authority.

The provision of the personal data by means of Mec-Oild website online forms is a requirement necessary for the supply of the requested products or services.

The giving of consent to the use of the personal data for marketing purposes is voluntary.

Mec-Oild does not use any automated decision-making, including profiling.
